Reading G4S's where G4S are the lead

First base - I'm not sure if this defiantly requires to be registered as I think its all down to weather that location is under the prison act 1954 (as its leased by south wales police) a quick google search brings up a lot of other organisations based in the building also. If it doesn't come under it, then I think it should be registered.

2nd, 3rd I think should be registered. The only question I have is the GP and nurses are sub contracted to kaleidoscope. As such would it be them who is registered, or would it be G4S as they lease the building, pay the bills and just pay kaleidoscope to provide that specific service to them.

DrugAid - where G4S are the lead

Site 1. I'm tempted to say yes, but like G4s that arrangement with the Dr's might be interesting. Also DAFS, GSSMS and social services. Would this cause any difficulties?

2nd base this one looks like it should be registered.

3rd base - this one looks like it should. I'm interested as CRI are mentioned here and they have not mentioned this location previously.

GDAS (from the sound of this these are sites are lead by all 3 but one of the three own / lease the building. This I think might cause difficulty on who should be registered) after talking to xxxxx xxxxxx it sounds like it might be better to register as a partnership for these 7 sites.
And looking at all 7 then they should be registered.

And on the spreadsheet there are about 37 sites but they have only provided detailed information on 13, I have requested further information on the missing ones and will forward on as soon as I hear back from them.
