

## **DEDDF CYNLLUNIO GWLAD A THREF 1990**

### **GORCHYMYN CAU PRIFFYRDD (3 LLYS LLEWELLYN, PEN-YR-EGLWYS, LLANILLTUD FAERDREF, PONTYPRIDD) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 (“Deddf 1990”) i awdurdodi cau’r darn o briffordd a ddisgrifir yn Atodlen 1 i’r Hysbysiad hwn. Mae Gweinidogion Cymru wedi eu bodloni bod angen cau’r darn o briffordd, ac nid awdurdodir ei gau ond er mwyn gwneud y datblygiad yn unol â’r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan Gyngor Bwrdeistref Sirol Rhondda Cynon Taf ar 7 Medi 2023 o dan y cyfeirnod 23/0789/10 ac a ddisgrifir yn Atodlen 2 i’r Hysbysiad hwn.


Caiff unrhyw berson a dramgyddir gan y Gorchymyn, ar y sail:

## **TOWN AND COUNTRY PLANNING ACT 1990**

### **THE STOPPING UP OF HIGHWAYS (3 LLYS LLEWELLYN, PEN-YR-EGLWYS, LLANTWIT FARDRE, PONTYPRIDD) ORDER 2024**

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 (“the 1990 Act”) to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The Welsh Ministers are satisfied that stopping up is necessary, and it will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Rhondda Cynon Taf County Borough Council on 7 September 2023 with reference 23/0789/10 described in Schedule 2 to this Notice.

The Stopping Up of Highways (3 Llys Llewellyn, Pen-Yr-Eglwys, Llantwit Fardre, Pontypridd) Order 2024 (“the Order”) ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge between normal office hours at Church Village Public Library, Garth Olwg Community Campus, St Illtyds Road, Church Village, CF 38 1RQ, or may be obtained free of charge from the address below quoting reference qA1908847.


If a person is aggrieved by the Order, on the grounds that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 2 May 2024 make an application for the purpose to the High Court.

**(All measurements are approximate)**

**Length of highway to be stopped up**

An irregular shaped length of highway located on the eastern side of Pen-Yr Eglwys opposite the junction leading to Heol Bryn Heulog and to the rear of the property know as 3 Llys Llewellyn, Llantwit Fardre, Pontypridd, with a maximum length of 11 metres and a maximum width of 4.5 metres.

Change of use of land to extend garden curtilage to the rear of the property known as 3 Llys Llewellyn, Llantwit Fardre, Pontypridd, CF38 2HQ.
