

**GORCHYMYN CEFNFFORDD YR A470 (LLYS-
WEN, POWYS) (GWAHARDD CERBYDAU
DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn tra bo gwaith yn cael ei wneud ar gefnffordd yr A470, neu gerllaw iddi, yn Llys-wen yn Sir Powys.

Effaith y Gorchymyn fydd gwahardd dros dro bob cerbyd rhag mynd ar y darn o gefnffordd yr A470 sy'n ymestyn o ganolbwynt ei chyffordd â'r A479 yn Llys-wen hyd at bwynt 60 o fetrau i'r de-orllewin o'r gyffordd honno.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r gogledd o ben deheuol y ffordd sydd ar gau fydd mynd ar yr A470 tua'r de-orllewin hyd at ei chyffordd â'r A438, ymuno â'r A438 tua'r dwyrain, yna'r A479 tua'r gogledd hyd at ei chyffordd â'r A438/A479, troi i'r chwith a pharhau tua'r gogledd-orllewin ar yr A479 i ailymuno â'r A470. I'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r de o ben gogleddol y ffordd sydd ar gau.

Disgwylir y bydd y gwaharddiad dros dro, y codir arwyddion priodol yn ei gylch, yn weithredol o 08:00 o'r gloch ar 23 Medi 2024 tan 19:00 o'r gloch ar 13 Hydref 2024 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod yr amseroedd a'r dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A470 TRUNK ROAD (LLYSWEN, POWYS)
(TEMPORARY PROHIBITION OF VEHICLES)
ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary whilst works are undertaken on or near the A470 trunk road at Llysven in the County of Powys.

The effect of the Order will be to temporarily prohibit all vehicles from proceeding on the length of the A470 trunk road that extends from the centre-point of its junction with the A479 at Llysven to a point 60 metres south-west of that said junction.

The alternative route for northbound vehicles from the southern extent of the closure will be via the south-westbound A470 to its junction with the A438, join the eastbound A438, then the northbound A479 to its junction with the A438/A479, turn left and continue north-westbound on the A479 to rejoin the A470. Vice versa for southbound vehicles from the northern extent of the closure.

The temporary prohibition, which will be signed accordingly, will operate from 08:00 hours on 23 September 2024 until 19:00 hours on 13 October 2024 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the times and dates specified above it will remain valid for a maximum period of 18 months as a contingency should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
