- 1.In reporting on this fund, has ABUHB informed Welsh Government that it is feasible to build the new Abermedical Centre premises on land West of Brynhafod Road, Abertridwr. I request any documentations of all reports/discussions/meetings that have taken place.
- 2.In reporting on this fund, has ABUHB informed Welsh Government it has had contact with the owner, or their representative, of land West of Brynhafod Road, Abertridwr. I request any documentations of all discussions/meetings that have taken place.
- 3. In reporting to Welsh Government on this funding, has ABUHB bought or leased the land West of Brynhafod Road, Abertridwr, for the building of the new Aber Valley Health and Wellbeing Centre and Aber Practice Development.
- 4. Has funding grant ATISN 19753, Health and Social Care Integration and Rebalancing Capital Fund, used funds to purchase or lease the land West of Brynhafod Road, Abertridwr.
- 5. Has the land/property acquisition category of £250,000 as set out in document ATISN 19753 Integration and Rebalancing Capital (IRCF) application Fund been spent by ABUHB?
- 6. From reporting to Welsh Government on this fund, is ABUHB aware of a covenant, or any restrictions for purchasing or building on the land West of Brynhafod Road, Abertridwr?
- 7. Has it been reported to Welsh Government that the original proposal to replace the existing Aber Medical Practice, Senghenydd Health Centre, and the Branch Surgery of the Nantgarw Practice, and relocate them to the new Abermedical Centre premises, as outlined in the ATISN 19753 application, is still in effect?
- 8. I request all reports or email correspondence with ABUHB and the Welsh Government in relation to ATISN 19753; Health and Social Care Integration and Rebalancing Capital Fund from Sept 2024 to date of this email.
