Thank you for your request which I received on 10 February 2025. You asked for the following information:

- 1. What was the total cost to Welsh Government of preparing the Senedd Cymru (Electoral Candidate Lists) Bill?
- 2. How much did the Welsh Government spend procuring advice/consultancy services from external organisations to prepare the Senedd Cymru (Electoral Candidate Lists) Bill?
- 3. How much did the Welsh Government spend consulting on the Senedd Cymru (Electoral Candidate Lists) Bill?

Our response

Some of the information you requested is provided below. However, not all of the information you have requested is held by the Welsh Government.

The cost of external legal advice that the Welsh Government received in relation to the Senedd Cymru (Electoral Candidate Lists) Bill is £38,100. This was incurred prior to introduction of the Bill. I can confirm that no other external services were commissioned for the Bill by the Welsh Government.

Any costs incurred in respect of Welsh Government Civil Servants time spent working on the Bill cannot be provided. The reason for this is that the Welsh Government does not record time spent by officials against specific activities. I am therefore unable to provide a breakdown of the cost of work on the Bill separate from the Senedd Reform programme as a whole. The allocation for the Senedd Reform programme overall was £2.2m in 2023-24 and £1.2m in 2024-2025.
