Good morning [Redacted],

I am hoping you will be able to help with a matter that has been brought to our attention.

A concerned member of the public has written about work that has been carried out at New Bethel Chapel in Sketty which is considered to change its appearance. It is suggested that the works are either damaging or of poor quality - this includes new

doors of a different design that have been fitted with dangerous, poor quality furniture; a central heating gas flue sticking out of a window; significant areas of distress to the pointing and stonework in the area of the flue. This seems to have caused penetrating damp and a vertical crack to an inside wall. I understand such issues are a matter for your authority, and I will direct this enquiry to you, but can you give me the background to this – does the building benefit from lbc, or is any action being considered?
