The quotation is based on the use of <u>14m</u> pipe lengths as specified in the drawing, and/or the bill of materials.

Should the lengths or any other details change, we reserve the rights to amend/revise our price in accordance with the amendments.

Delivery Conditions

Should carriage be required; prices are inclusive of delivery by road to either a hard stand at site or a depot.

Subsequently; the contractor is responsible for all handling, off-loading and storage at the delivery point.

Reference must be made to SDS Limited, guidelines. HIAB deliveries are available in on request and charged accordingly.

All regional transport restrictions, such as use of articulated vehicles; must be advised to us at the initial stage of quotation.

SDS Limited. reserve the rights to amend transport pricing accordingly.

In cases whereby nylon lifting straps are to be provided by SDS Limited...

it is a fundamental ask that they be returned with the vehicle driver upon uploading and with immediate effect.

Straps not returned within a four weeks of the dated proof of delivery ticket, shall be subject to an additional charge of £150.00 per said item.

Other devices such as: lifting eyes or beams that may be necessary to provide shall also be charged at their residual value, should they not be returned.

Installation

The contractor shall be responsible for installing the Weholite system in accordance with SDS Limited.

guidelines and the approved drawings, should they be provided.

Due care should be taken to ensure that pipes are joined using the appropriate methodology and the gaps are minimised in accordance with the installation instructions.

SDS Limited. will in no way, accept any liable responsibility for installed joints that are affected by poor installation practice.

Poor installation of the pipes or failure to follow SDS Limited. guidelines that results in the welding process being delayed,

shall also be subject to additional charges. Joints that require filling or plating due to poor alignment will also be chargeable.

Additional site works will be charged at £3000.00 per day.

Prior to site attendance; both a method statement and risk assessment shall be issued giving details of the procedures and process of site extrusion Jointing. This will need to be approved prior to site visit.

If specified; prices inclusive of fully trained two person welding team. The 'top man' should be provided by the contractor.

SDS Limited. can, of course supply a third man upon request, however; this to will be charged accordingly.

Any additional personnel and or safety equipment, other than that specified in the approval method statement/risk assessment should be provided by the contractor.

Pipes must be clean and free from water to ensure that the welders can maintain full continuity of work. Failure to comply with this will result in additional charges being applied.

Site extrusion jointing shall be tailored to meet the contractor's programme. To ensure this; a minimum of three weeks' notice should be advised for site attendance.

This can be discussed in the duration of the prestart meeting.

A prestart meeting should be arranged with SDS Limited. in order to discuss all of the above points

in more detail and well in advance of installation, thus providing supreme preparation.
