This advice is given in response to scoping opinion as to the contents of an Environmental Impact Assessment (EIA) that will be submitted in support of an application for the Gaerwen Wind Farm.

A scoping document has been prepared for the environmental impact assessment by RSK and cultural heritage is covered in section 3.3. In general we agree with the proposed method of assessment but in our opinion the study area for grade II listed buildings should be extended to 5km given that tjhese are National designations.

We agree that as the proposed development is not inside a registered historic landscape an ASIDOHL assessment is not required. Instead the impact of the proposed development on the setting of the registered historic landscapes should be considered using the guidance given in "The Setting of Historic Assets in Wales".
