1. The number of 18–25-year-olds sectioned under the Mental Health Act.

Our Response

We do not currently hold data by age on the number sectioned under all sections of the Mental Health Act. Though this is currently in the process of being collected for future publications. However, we do currently hold data on those between the ages of 18-25 who are detained under sections 135 and 136 of Mental Health Act since 2019 and this is provided in the table below:

We did not start to collect/publish the data until Q1 2019/20 so only have data available from that point so do not have from the beginning of 2019 as requested.
