Thank you for your request which I received on 9 February 2025. Further to the response issued to you under ATISN 22115, you asked for the following information:

*The total amount of grant funding and central budget allocations made by the Welsh Government to each organisation listed for the financial years 2022/23 and 2023/24.g*

*If any organisations on the list do not receive direct budget allocations, grants, or payments from the Welsh Government, please indicate this.*

**Our response**

Welsh Government finance systems record financial transactions with entities either as procured activity or grants. 'Central budget allocations' is not a form of financial transaction analysis available within our systems.

We have therefore analysed in response to this request all information held regarding 'grants' where organisations are provided with grant funding, rather than procured services payments.

With regard to the organisations listed on [Organisations | GOV.WALES](#) :

- Student Loans Company has been excluded from the analysis as the arrangement is a co-funding arrangement with other UK nations for the provision of Student Loans administration services.
- CADW is an operating unit of Welsh Government and therefore has been excluded
- Royal Commission on the Ancient and Historical Monuments of Wales operates within the Welsh Government and therefore has been excluded
- No funding is provided from Welsh Government to Audit Wales – only payments for audit services rendered it is therefore excluded
- No funding is provided from Welsh Government to the Auditor General for Wales
- Care Inspectorate Wales operates within the Welsh Government and therefore has been excluded
- Healthcare Inspectorate Wales operates within the Welsh Government and therefore has been excluded
- National Procurement Service is an operating unit of Welsh Government and therefore has been excluded
- Planning and Environment Decisions Wales operates within the Welsh Government and therefore has been excluded

The attached disclosure details grant payment information provided directly from Welsh Government to the organisations listed for 2022-23 and 2023-24. Where no data has been provided there are no grant payments for that organisation in the period requested.
