Subject: RE: Swansea Bay maternity and neo-natal services intendent review

Please find attached a response which has been drafted in conjunction with colleagues in maternity and neonatal policy team.

The Minister's correspondence address and the Quality and Nursing Directorate mailbox were copied into the family's letter to the Chair of the review, Margaret Bowron KC on 14 February. Within the letter, the family explained they were communicating on behalf of 29 families. The key concerns as highlighted in their letter are:

- You did not confirm any of the factual inaccuracies you accuse us of making.
  We were simply asking very relevant questions around the review, your
  independence and why you and SBUHB have deliberately chosen to exclude
  affected families from involvement in setting up any aspect of the review. You
  avoided answering our questions by gaslighting us, forcing us to question our
  own judgement in seeking clarity regarding the review.
- The arrogance of your email sent to a family member living with the lifelong impact of the SBUHB care failings is completely unacceptable and highlights your inexperience in engaging with families and seeking their views. Given that you have been appointed as Chair, this has added additional concern regarding how you can ensure that families living with trauma can be treated with dignity and respect, given that you have evidenced an inability to do this in the very limited amount of communication we have had to date.
- A rushed review will undermine the whole process and will be set to fail as
  things will be missed. As a group of affected families who have spent a lot of
  time engaging with professionals who have conducted other maternity
  reviews, we are confident that your 'first urgent priority' should be to sit down
  with affected families to discuss the terms of the review and selection of
  experts. Best practice and legislation all determines that you should not be
  making these decisions without affected family involvement.
- Emma Woollett, Chair of SBUHB, was heavily involved in allowing the
  maternity failings to go on for so long. She chaired an Executive Board that
  failed to address four serious maternity risks on the Health Board Risk
  Register over many years. Her role in the selection process should not have
  been allowed, as a result your appointment should not have taken place.
- Your attempts to gaslight us before the review has even begun is wrong and distressing. Your involvement should never have been allowed considering your past dealings with SBUHB and other Welsh health boards. Also, we have seen no evidence that you have Chaired a maternity review of this scale in the past.

As a result of the above and on behalf of 29 affected families we ask you
acknowledge that you are not the correct person to carry out this role and to
immediately stand down from your role as Chair of the Oversight Committee
so that someone with more appropriate experience may be appointed.

What are the health board doing in response to this:

The health board are not engaging in correspondence with the families on this matter. The health board has confirmed that the Chair and independent panel will have the authority to review, modify and agree the terms of reference for the review (currently in draft form), which includes the time period being considered and the corresponding clinical cases for review. They will also be responsible for determining the approach for family and service-user engagement within the review process, which will be led by an independent engagement specialist. The Chair is currently identifying and appointing the individual members of the independent oversight panel and the corresponding review teams, and the health board will make a further announcement about these appointments in due course.

What are Welsh Government doing in response to this:

A decision has been taken that it is not appropriate to reply to this letter as officials and the Minister were ccs on the correspondence and not direct recipients – this has resulted in discussions on social media

Enhanced monitoring meetings are taking place and this will be discussed with the health board at the next meeting (28 February).
