6. **Maternity and neonatal services**

The health board provided an update on workforce numbers, training and incidents. A number of vacancies have been over recruited to. On incidents, it was noted as maternity adverse outcomes was the highest reported incidents and this was broken down further into sub categories with term admission to NICU and infants born under 10th centile as the highest within that category. The health board agreed to provide an update on the midwifery numbers based on current position and those who will be newly qualified in September.

On NRIs, there has been a 50% increase in neonatal, though the numbers are small. The health board is reviewing data from 2022. The health board has had three must reports to NHS Executive and MBRRACE so far in 2024. The health board reported one neonatal death in April 2024. On IPC, there were no reported HCAs in March, but there will be a klebsiella reported in April.

The health board provided information on the 'Friends and Family' report and there had been favourable feedback received on neonates and there are 'you said, we did' boards in wards. For maternity, there are concerns around delays in induction and providing pain relief. The health board has improved induction and reduced delays and has been teaching patients to self-manage their pain relief and midwives have introduced more regular medicine rounds. This has resulted in the satisfaction score increasing.

HIW reports – the health board provided an update on the unannounced visit by HIW in April. There were three immediate improvement actions, two were resolved immediately and one included within the report. The health board has received the draft report and is checking for accuracy. The final report is due for publication in July.

The health board also provided an update on the 2023 and 2019 inspections and the 2020 review. The health board confirmed that regarding the second action in the 2019 report, they are aiming for 95% compliance.
