## **ATISN 24496 Flood Prevention**

### **Information requested**

Thank you for your request which I received on 6 March 2025. You asked via Written Question 95927:

- How much of the £214 million over three years to prevent and protect communities from flooding announced on 15 March 2022 has been spent in Carmarthenshire so far, giving details of a) those plans, b) how much has been earmarked to be spent and c) on which projects?

### **Our response**

Since 2022, Welsh Government has funded Carmarthenshire County Council and Natural Resources Wales to develop flood schemes in Carmarthenshire. We have provided Carmarthenshire County Council £572k to construct schemes and we have also made available £1.62m to develop flood schemes. Meanwhile, we have funded Natural Resources Wales £8.76 million to progress flood schemes in Carmarthenshire.

A breakdown of this investment is provided below, per Risk Management Authority.
