Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A5, drwy arfer y pwerau a roddir iddynt gan adrannau 82(2) a 83(1) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the relevant length of the A5 trunk road, in exercise of the powers conferred upon them by sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984(1), make this Order.

Mae Gweinidogion Cymru wedi rhoi hysbysiad cyhoeddus o'u bwriad i wneud y Gorchymyn hwn yn unol ag adran 83(1) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984.

The Welsh Ministers have given public notice of their intention to make this Order in accordance with section 83(1) of the Road Traffic Regulation Act 1984.

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A5 (Man i'r Gogledd o Fethesda, Gwynedd) (Dileu Cyfyngiad) 202- a daw i rym ar **** 2025.

Title and commencement

1. The title of this Order is the A5 Trunk Road (North of Bethesda, Gwynedd) (Derestriction) Order 202- and it comes into force on **** 2025.

2. Yn y Gorchymyn hwn—
ystyr “y gefnffordd” yw cefnffordd yr A5 Llundain i Gaergybi.

Interpretation

2. In this Order—
“the trunk road” means the A5 London to Holyhead trunk road.

Derestriction

3. The length of the trunk road that extends from a point 135 metres west of the centre-point of its junction with Tal Gae to a point 19 metres east of the centre-point of its junction with Tyddyn Iolyn, north of Bethesda, Gwynedd shall cease to be a restricted road for the purposes of section 81 of the Road Traffic Regulation Act 1984.
