Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 29 April 2025 relating to the energy usage at Wrexham Maelor Hospital. You requested the following:

- *To provide metered energy usage data for Betsi Cadwaladr Wrexham Maelor Hospital. Data to include:*
 - *statutory electricity, gas and water for a 24-month period*
 - *the applicable unit rates i.e. kWh, litres*
- *To provide the information in either billed format (half-hourly or quarterly), spreadsheet or similar.*

Your personal information will then be disposed of securely.

- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
