This discussion paper has been written by officials of the Welsh Government.

Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

Latest RA data for the 2025-26 Settlement

Summary

- 1. This paper looks at the impact on the 2025-26 Settlement of the change in Revenue Account (RA) data between 2023-24 and 2024-25.
- 2. This paper looks at the financial implications of updating the RA data in the Standard Spending Assessment (SSA) build with a view to using this data within the 2025-26 Settlement. Please note that these figures are being run against the 2024-25 Final Total SSA Settlement distribution for the purposes of exemplification. The data is currently provisional and subject to review.

Views sought

3. For DSG to specify whether the 2024-25 RA provides a representative picture of the general sectors at a Wales level, and if so to note the impact on the distribution of the Settlement of using the latest RA data in the Settlement model.

Background

- 11. The calculation of SSA <u>sector</u> totals uses the most up-to-date information at a total Wales level on the pattern of <u>budgeted Unitary Authority expenditure</u> (<u>sourced from RA returns</u>). For the 2024-25 Settlement, the 2023-24 RA forms were used. This paper updates the RA expenditure from 2023-24 to 2024-25.
- 12. This paper provides an exemplification of the isolated change of the RA forms, run against the 2024-25 Settlement.
- 13. The calculation of SSA <u>service</u> totals within each sector uses information at a total Wales level on the pattern of <u>actual Unitary Authority expenditure (sourced from RO forms)</u>. For the 2024-25 Settlement, expenditure data taken from the 2022-23 RO forms were used. For the 2025-26 Settlement, expenditure data taken form the 2023-24 RO forms will be considered. This will be the subject of a further paper.

Changes in the RA data

- 14. <u>Table 1</u> in <u>Annex A</u> shows the budgeted RA expenditure data for 2023-24 and 2024-25 split into the 6 sectors used in the SSA calculations (Schools services, Other Education, PSS; Transport, Fire and Other Services). Compared to the previous year, the sector with largest monetary increase in budgeted expenditure was the *PSS* sector (up £228.2m) this was also the largest percentage increase (up 9.9%).
- 15. <u>Table 2</u> shows the proportion of RA expenditure for each sector and the change from 2023-24. This shows that the *PSS* sector had the largest increase (up 1.37 percentage points), and the other sector had the largest decrease (down 1.14 percentage points).

Redistribution implications

- 16. <u>Table 3</u> in the Annex shows the changes in the 2024-25 Aggregate External Finance (AEF) when updating the RA data. In updating the RA data through the model, we also disregard any prioritisation that was previously in place as this should now flow through the financial data. This is to isolate the effect the latest RA data has on the 2024-25 Settlement allocations.
- 17. Rhonda Cynon Taf and Caerphilly have the largest monetary increases in AEF of £843k and £516k respectively. The largest monetary decreases in AEF are for Powys (down £1,086k) and Gwynedd (down £944k).

Conclusion

- 18. DSG are asked to consider whether the data provides a representative picture across the sectors, ahead of the 2025-26 settlement.
- 19. If so, it is the intention to use the latest (2024-25) RA data in the 2025-26 Settlement in line with Society of Welsh Treasurers (SWT) principles. Further analysis will be provided later in 2024 to look at the impact of updating to the latest RO data.
