For each financial year from 2017/18 to 2024/25:

- List the number of second homes at the start of the financial year in Wales.
- Break down those figures by council area
- List the number of holiday lets at the start of the financial year in Wales.
- Break down those figures by council area

For each financial year from 2017/18 to 2024/25:

• At the end of the financial year, list the number of second homes converted to become holiday lets during that year (and so not eligible to pay council tax).

Our response

The data on number of second homes and breakdown by council area is in the public domain and has been forwarded to you separately.

The number of holiday lets and breakdown by council area is attached as a separate spreadsheet.

The Welsh Government does not hold 2017-18 data on the number of self-catering holiday lets on the non-domestic rating list.

The Welsh Government does not hold information on the number of second homes converted to become holiday lets.
