This discussion paper has been written by officials of the Welsh Government. Ministers have not had an opportunity to comment on the contents. Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

Employer NI contributions

Summary

1. This paper set out possible options on the distribution of any funding received from the UK Government for the increase in employer's national insurance costs.

Views sought

2. DSG are asked to discuss the options presented and any further options to be investigated in advance of any funding notification, with the aim of agreeing a fair way forward for all authorities.

Background

- National Insurance is not devolved and the UK Government announced increases to the employer's national insurance rate in the October 2024 Autumn Statement.
- 5. The UK Government has confirmed it will provide funding to public sector employers to cover the increased costs of employer National Insurance contributions. It will use the official ONS definition of a public sector employer.
- 6. The UK Government has now said they are providing a Barnett share based on England's costs not Wales' actual needs.
- 7. Our initial estimate is devolved public sector employers in Wales face a £253m. The approach the UK Government is taking leaves us with a significant shortfall. We estimate we could be circa £65m a year short on the extra costs public services in Wales will have to pay. This is approximately 25%.
- 8. Final confirmation of how much additional funding we will receive to support the additional costs to devolved public sector employers will be confirmed through UK Main Estimates, published on 16/5/25. Welsh Treasury are currently working through the detail.
- 9. The latest estimates collected through the WLGA give costs of:

Local authority staff - including teachers

- 10. Irrespective of the total amount of funding available we know that will be difference between all 22 authorities in Wales of where the impact of national insurance costs impact.
- 11. Authorities have different mixes of services delivered by in house staff, through commissioned work or through contracts. This can include provision of social care, housing services, school catering as just a few examples.
- 12. It is expected that although local authorities themselves will see an increase in their own staff costs, there will also be an impact on commissioned rates and contract amounts as the NI cost impact local government partners and suppliers, whether they be private companies or the third sector.

Distribution options

13. At the last DSG the group discussed three options for funding distribution – at the last meeting it was felt that a distribution that move across into the settlement easily would be the most sensible way forward. Annex A shows an exemplification of the differences based on the revised forecasts collected by the WLGA.

Discussion point - are there any different views given the expected quantum?

- Option 1 Distribute funding based on directly employed staff, as per the WLGA data collection.
- Option 2 Distribute based on the overall local government settlement.
- Option 3 Distribute based on the SSA areas that are predominantly driven by staff costs (all education, personal social services, transport, other services).

Fire authorities

14. We understand the fire authorities have included the cost of the increased NI in their levy to local authorities already. Therefore any related funding will be directed to local authorities. The total estimated cost is £4m.

Discussion point – what is the best approach to distribution?

Distribution options

Option 1 – add into the total amount of funding and distribute on the agreed option for local authority staff.

Option 2 – collect exact information from fire authorities and fund specific amounts pro rata to the total available to the relevant authorities.

Option 3 – fund on the total Fire SSA

Option 4 – fund on the fire service IBA

National Parks

15. We understand the national parks levy is a proportion of the national parks grant. Therefore the increase in NI is not included and we propose to give any additional funding direct to National Park Authorities through a grant.

Discussion point – are DSG content with this approach?

Housing Revenue Account

16. Some authorities have HRA and related staff. This was not included in the original WLGA estimates for all authorities but is included in the revised estimated provided to treasury and the overall figure is fairly consistent for directly employed staff. Where authorities do not have HRA they will have contracted out provision to housing associations etc who are not covered by the government definition of public sector. They will therefore need to meet the increased costs from either efficiency or increasing income through rents.

Discussion point — — what is the best approach to distribution?

Distribution options

Option 1 – distribute pro rata based on estimates from local authorities with HRA

Option 2 – add to the total for local authorities and treat as any other commissioned / contracted service vs in house provision and distribute on the agreed methodology for the main local authority funding.

Way forward

- 17. Is there any else that DSG think that needs to be considered?
- 18. The proposed distribution will be circulated to FSG through the WLGA for agreement.
