

**GORCHYMYN CEFNFFORDD YR A4042
(CYLCHFAN MAMHEILAD, TORFAEN I LÔN
CROES-Y-PANT, PENPERLLENNI, SIR
FYNWY) (TERFYN CYFLYMDER 50MYA

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn sicrhau diogelwch ar y ffordd ar gefnffordd yr A4042, neu gerllaw iddi, rhwng Cylchfan Mamheilad, Torfaen a Lôn Croes-y-pant, Penperllenni, Sir Fynwy.

Effaith y Gorchymyn yw gosod terfyn cyflymder 50mya dros dro ar gerbyttfyrdd tua'r gogledd a thua'r de cefnffordd yr A4042 o bwynt 15 metr i'r de o linell ganol ei chyffordd â'r ffordd ymyl o'r enw Lôn Croes-y-pant hyd at ei chyffordd â phrif gerbyttfyrdd gylchredol Cylchfan Mamheilad.

Bydd y terfyn cyflymder 50mya, y codir arwyddion priodol yn ei gylch, yn weithredol o 00:01 o'r gloch ar 19 Gorffennaf 2025 am gyfnod o 12 mis. Disgwylir y bydd cais am Orchymyn Traffig terfyn cyflymder 50mya parhaol yn dilyn.

**THE A4042 TRUNK ROAD (MAMHILAD
ROUNDAABOUT, TORFAEN TO CROES-Y-
PANT LANE, PENPERLLENNI,
MONMOUTHSHIRE) (TEMPORARY 50MPH
SPEED LIMIT) ORDER 2025**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary in the interests of road safety on or near the A4042 Trunk Road between Mamhilad Roundabout, Torfaen and Croes-Y-Pant Lane, Penperlleni, Monmouthshire.

The effect of the Order is to impose a Temporary 50mph speed limit on both northbound and southbound carriageways of the A4042 Trunk Road from a point 15 metres south of the centreline of its junction with the side road known as Croes-Y-Pant Lane to its junction with the main circulatory carriageway of Mamhilad Roundabout.

The 50mph speed limit, which will be signed accordingly, will operate from 00:01 hours on 19 July 2025 for a period of 12 months. It is expected that an application for a permanent 50mph speed limit Traffic Order will follow.
