Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A477, a thrwy arfer y pwerau a roddir iddynt gan adran 82(2) ac adran 83(1) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the relevant length of the A477 trunk road, and in exercise of the powers conferred upon them by sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and Commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A477 (Cylchfan Carew Cheriton, Sir Benfro) (Dileu Cyfyngiadau) 2025 a daw'r Gorchymyn hwn i rym ar 18 Gorffennaf 2025.

1. The title of this Order is the A477 Trunk Road (Carew Cheriton Roundabout, Pembrokeshire) (Derestriction) Order 2025 and this Order comes into force on 18 July 2025.

Interpretation

2. Yn y Gorchymyn hwn ystyr "y gefnffordd" ("the trunk road") yw Cefnffordd yr A477 Sanclêr i Ddoc Penfro.

2. In this Order "the trunk road" ("y gefnffordd") means the A477 St Clears to Pembroke Dock Trunk Road.
