PEDW does not hold records of whether construction has started, or whether projects are operational. The Local Planning Authority (LPA) may hold this information.

PEDW does not hold records of the distance from the projects to residential houses. PEDW's standard retention period for case documents is one year from the date of the decision. The LPA's planning register is the formal record where plans and other documents from the application should be available.

The DNS system is operated on a total cost recovery basis. There is no cost to PEDW, as it is all recovered from the developer. There are fixed fees that the developer must pay at
