## Information requested

Thank you for your request which I received on 19 August 2025. You asked for:

- 1. For the years 2020, 2021, 2022, 2023, 2024 and 2025 to date, how many individual outbreaks of Highly Pathogenic Avian Influenza (HPAI) occurred at game farms containing pheasants and/or partridges in Wales?
- 2. For the years 2020, 2021, 2022, 2023, 2024 and 2025 to date, how many game farms containing pheasants and/or partridges in Wales were affected by an outbreak of HPAI.
- **3.** For the years 2020, 2021, 2022, 2023, 2024 and 2025 to date, how many pheasants and partridges on game farms in Wales were culled due to an outbreak of HPAI.
- **4.** For the years 2020, 2021, 2022, 2023, 2024 and 2025 to date, the total cost of each culling operation on game farms in Wales where an outbreak of HPAI occurred. To include the cost of staff to carry out the cull, the cost of disposal of the carcases, transport, the cost of the equipment (gas etc) to carry out each cull and any other associated costs.
- **5.** For the years 2020, 2021, 2022, 2023, 2024 and 2025 to date, how many game farm operations have received financial compensation from the Welsh Government for HPAI outbreaks?
