**Notice Under Section 1(6B) of the Ancient Monuments and Archaeological
Areas Act 1979
Prehistoric Rock Art at Tai'r Waun Isaf (GM637)**

Further to our previous correspondence, I am writing to notify you that, following consultation, the Welsh Ministers have included the above mentioned monument in the Schedule of monuments of national importance, as compiled and maintained under section 1 of the Ancient Monuments and Archaeological Areas Act 1979, on 19 May 2023. Interim protection ceases on the date of this notice, and formal protection commences.

The Welsh Ministers are also required to serve a notice on the owner of the monument who will have the opportunity to request a review of this decision.

I enclose a copy of the entry to the statutory schedule of monuments of national importance. The schedule entry explains the importance of the monument, the reason for its inclusion and the date it was included in the schedule. A map showing the extent of the area that is now included in the schedule is also enclosed.
