

**GORCHYMYN CEFNFFORDD YR A470
(CILFAN I'R DE O GYLCHFAN CYFARTHFA,
MERTHYR TUDFUL) (GWAHARDD
CERBYDAU DROS DRO) 2025**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, sy'n ofynnol oherwydd y tebygolrwydd o berygl i'r cyhoedd, neu o ddifrod difrifol i'r ffordd na ellir eu priodoli i waith, ar gefnffordd yr A470 i'r de o Gylchfan Cyfarthfa, Merthyr Tudful, neu gerllaw iddi.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai sy'n cael eu defnyddio gan y gwasanaethau brys neu gan contractwr y cytunwyd arno wrth osod neu gynnal a chadw cyfarpar priffyrdd, rhag mynd ar y darn o'r gilfan sy'n gyfagos i gerbyttffordd tua'r de y gefnffordd rhwng Cylchfan Cyfarthfa a Chylchfan Rhyd-y-car.

Daw'r Gorchymyn i rym ar 20 Hydref 2025. Disgwylir y bydd y gwaharddiad dros dro yn weithredol o 00:01 o'r gloch ar 20 Hydref hyd 23:59 o'r gloch ar 2 Tachwedd 2025, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 6 mis ar y mwyaf.

**THE A470 TRUNK ROAD (LAY-BY SOUTH OF
CYFARTHFA ROUNDABOUT, MERTHYR
TYDFIL) (TEMPORARY PROHIBITION OF
VEHICLES) ORDER 2025**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is required due to the likelihood of danger to the public, or of serious damage to the road not attributable to works, on or near the A470 trunk road south of Cyfarthfa Roundabout, Merthyr Tydfil.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services or by an agreed contractor in the setting-up or maintenance of highway apparatus, from proceeding on the length of the lay-by adjacent to the southbound carriageway of the trunk road between Cyfarthfa Roundabout and Rhyd-y-car Roundabout.

The Order comes into force on 20 October 2025. The temporary prohibition is expected to operate from 00:01 hours on 20 October until 23:59 hours on 2 November 2025, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above, it will remain valid for a maximum period of 6 months.
