In the wake of the acquisition of Case-UK C.I.C. by The BUSY Group UK on 24th September 2024, I write to update on some necessary operational and management changes to Case-UK C.I.C.

Firstly, Case-UK C.I.C. continues to retain its separate legal identity and status. Accordingly, the ownership, management structure, and controlling interests since the acquisition took place remain unchanged, and there have been no transfers of voting rights, shares, or executive authority that would constitute a shift in control.

Case-UK C.I.C. continues to operate as a separate legal entity to deliver the specification for each of the lots for the In-Work and Out of Work Support Services Contracts; however, there have been some personnel changes that we wish to inform you of; namely [REDACTED], is due to leave our employment on the 30th June 2025, and [REDACTED], while continuing in the business, is adopting an advisory role to the UK Group. [REDACTED] remains a director of The BUSY Group UK.

At the present time, the operational management of Case-UK C.I.C is being overseen by myself in my role as a Director of Case-UK C.I.C.

The operational leadership of the projects remains unchanged, with [REDACTED], [REDACTED] and [REDACTED] for the In-Work Support Service Contract and [REDACTED] and [REDACTED] for the Out of Work Support Service Contract.

To enhance the level of operational management for the delivery we are in the process of recruiting into leadership positions.
