

# MINISTERIAL ADVICE - Ynni Cymru Capital Grant Scheme (Year 2 - FY 2025-26)

Subject	Ynni Cymru Capital Grant Scheme - Approval of Projects and a request to transfer money between Energy BELs
100-word summary	The Ynni Cymru £10,000,000 Capital Grant Scheme for Smart Local Energy System (SLES) projects closed for applications on 16 June.
	This advice outlines the Approval Board recommendations to award capital grants to a total of 48 projects which will require a total grant award of £12,906,707.
	This will be funded from the £10,000,000 already allocated to the Ynni Cymru Capital Grant Scheme available in BEL 3775.
Timing	A response if required before the proposed announcement on the funded projects which is provisionally planned for the 15 September.
Recommendation	<ul> <li>Approve the award of grant to projects outlined in Annex to the total value of £12,907,000. This includes approved capital funding for the project of £10,000,000 from Ynni Cymru Capital BEL and £2,907,000 from Green Energy Capital BEL.</li> <li>Approve</li> </ul>

#### **ADVICE**

#### **Background**

- 1. Established by Welsh Government in 2023, the Ynni Cymru programme aims to ensure that energy generation benefits are retained locally, promoting community ownership of integrated renewable energy assets as a central strategy in the transition to a low-carbon economy. The programme also aims:
  - To accelerate the transition and deployment of Smart Local Energy Systems ("SLES") across Wales.
  - To expand locally owned renewable energy used and generated in Wales.
  - To optimise the efficiency and effectiveness of locally owned renewable energy use and generation projects.
  - To facilitate a just transition to net zero, retaining the benefits for Welsh communities.
- 2. The core focus for Ynni Cymru was agreed in 2023, to be the development and delivery of SLES.
- 3. A SLES is a way to bring together different energy assets in a local area and operate them in a 'smarter' way, which could be more productive or more integrated, whilst seeking to maximise benefits to both local communities and the local energy network.

#### **Capital Grant Scheme**

- 4. This is the second round that Welsh Government has funded following the successful deployment of 32 projects which were awarded funding in the 2024/25 financial year. Welsh Government has awarded £10,000,000 capital funding to Ynni Cymru in the current financial year, to fund the deployment of SLES projects across Wales, see MA-RE-10964-25 for information.
- 5. The 2025/26 Ynni Cymru Capital Grant scheme was launched on 2 May and closed to applicants on the 16 June. The scheme was open to community energy organisations and groups, public sector bodies, and small and medium sized (SMEs) businesses operating in Wales.
- 6. This year, reflecting on feedback from year one of Ynni Cymru scheme, two application pathways were created. Pathway 1 is for applications up to £250,000 in value and was designed to be more appropriate for smaller-scale projects with reduced application requirements for applicants. Pathway 2 is for applications between £250,000 and up to £1,000,000 in value and was designed for more complex projects, with some additional requirements and evidence required from applicants. Also reflecting feedback from last year, we modified the level of funding available depending on sector of applicant, to recognise SMEs and ensure that public sector bodies have wider access to alternative funding for projects. As a result, projects could apply for up to 100% grant funding if they were classed as a community organisation, up to

90% grant funding if classed as an SME and up to 75% grant funding if classed a public sector body.

#### **Assessment Process**

- 7. 116 applications were received and were allocated to two separate assessors. SME applications were assessed by two assessors from the Ynni Cymru team and public/community sector applications were evaluated by assessors both from Ynni Cymru and the Welsh Government Energy Service (WGES). The involvement of WGES was to ensure that the public sector/community projects to be funded by Ynni Cymru added value to the existing funding to the sector manged by WGES.
- 8. In all cases, assessors carried out an independent assessment of each application, against the scheme criteria, to ensure their proposals met outlined thresholds, including being robust, viable and deliverable by the scheme deadline which is by the 31 March 2026.
- 9. Once the independent assessments were completed, moderation was carried out for those applications where scores differed by 10% or more between assessors, or where one assessor had failed an application, and another had passed the same application. In addition to the moderation carried out, a final quality assurance was conducted.
- 10. As agreed in the scheme review before launch, projects achieving a pass score above the minimum pass threshold mark of 60% and located in the 20% most deprived areas of Wales (according to the Welsh Index of Multiple Deprivation¹), received a score uplift of 5% to support Welsh Government and Ynni Cymru objectives around a just transition to net zero.
- 11. Table 1 provides a summary of the applications received. It provides the sectoral split, pathway split, and a breakdown of the number of applications that passed the assessment process.
- 12. Of the 116 applications which were received, 81 applications (70%) passed the initial assessment process representing a potential total grant award value of £20,697,000. Projects represented a good spread of applications across community, SME and public sectors.
- 13. These applications were then further scrutinised for their suitability to be grant funded and ranked in order so that the £10,000,000 capital funding could be awarded to the highest scoring projects.

#### **Approval Panel**

- 14. An approval panel of Welsh Government officials reviewed the assessment findings on 18 July.
- 15. Of the 81 applications that passed the initial assessment process, 48 have met the requirements to be funded. Of these 48 projects, 38 can be funded primarily out of the existing £10,000,000 capital allocation to the scheme already agreed, with a further 10 projects also meeting the criteria to be funded, which will be bought forward subject to overall confirmation that funds available in the Energy Division's funding allocation can be moved into the Ynni Cymru BEL.
- 16. The recommended projects for approval are detailed in Annex 2 and split into projects under £250,000 and over £250,000, in line with how the applications were submitted and subsequently scored.
- 17. Decisions to award funding above £250,000 are to be made by the Cabinet Secretary. As per other programmes, the decision to award funds up to £250,000 can be delegated to officials. None of the projects listed which exceed the £250,000 threshold have been identified as being in the constituency of the Cabinet Secretary.
- 18. There are 9 projects that received a score uplift based on deprivation.
- 19. For simplicity, this advice will seek the Cabinet Secretary's agreement to all projects which have met the threshold for grant funding, which is a total of 48 projects which require a total of £12,907,000 capital funding.

20. It is important to note that the confirmed total grant value of Ynni Cymru schemes may be subject to minor changes as further confirmation work proceeds following the announcement of successful projects. Any changes will likely see a reduction in capital grant, not an increase. This is the experience from the learnings in the 2024-25 scheme as projects reappraise what can be delivered within the grant window. Any underspend will be reported in a timely way so that it may be redeployed as appropriate.

- 21. Prior to grant award, engagement and clarifications with all projects has I taken place to confirm the exact eligible grant value. Due diligence of the SMEs proposed to be awarded funding will be undertaken before Grant Offer Letters are issued.
- 22. Grant Offer Letters will be issued to successful organisations in early September to enable projects to mobilise in readiness for completion by end of March 2026. The letters will state that 'up to value' of the grant will be available unless a variation is requested and approved.

#### **Financial Implications**

23. The total costs for this advice are £12,907,000 and can be fully met from the Ynni Cymru BEL 3772 (£10,000,000) and a transfer from unallocated capital available in the Green Energy BEL 1280 (£2,907,000). All are within the remit of as for Energy and all funding has been cleared in the Energy Division Budget MA-RE-1227-25.

#### Risks

24. There are challenges associated with delivering a capital fund within the financial year, such as contractors not being able to deliver projects in the allotted time, and this could bring risk of underspend. This risk has already been mitigated by scoring deliverability in the assessment process and will be further mitigated by clarifying grant draw down conditions in the Grant Offer Letter.

25. Projects are only being awarded a grant if there is a high confidence in deliverability. Match funding, as outlined in the scheme guidance, is designed to maximise spend of the grant fund, and arrangements for match funding are known to be advanced. Annex 2 details projects and the value of grant and the total project costs, to illustrate the match funded projects.

#### **Subsidy Control**

26. This support is a subsidy. Accordingly, awards will be made via the Welsh Government's 'Subsidy Scheme for Local Energy Support (Wales)' SC.11250 to ensure compliance with the Subsidy Control Act 2022.

#### **Communications and media handling**

- 27.A press release will be issued once the Grant Offer Letters have been distributed. Officials will liaise with Welsh Government communications team with the intention that you visit a successful applicant.
- 28. There are proposals to undertake visits to successful schemes awarded in the 2024-25 financial year, to mark the announcement of the successful applications for 2025-26 financial year.
- 29. September 15<sup>th</sup> -17<sup>th</sup> is the provisional date window planned for activities. Suitable press releases and media will be developed to coincide with proposed visits.
