The Welsh Ministers, in exercise of their powers under section 247 of the Town and Country Planning Act 1990(1), make this Order.

Title and Commencement

1. The title of this Order is The Stopping Up of Highways (Hafod Y Bryn, 37 Cae Mair, Beaumaris, Isle of Anglesey, LL58 8YN) Order 202- and it comes into force on ***** 202-.

Interpretation

2. In this Order—

“the Council” (“*y Cyngor*”) means Isle of Anglesey County Council;

“the deposited plan” (“*y plan a adnewwyd*”) means the plan entitled “The Stopping Up of Highways (Hafod Y Bryn, 37 Cae Mair, Beaumaris, Isle of Anglesey, LL58 8YN) Order 202-” with reference qA2326075 which accompany this Order;

“the developer” (“*y datblygwr*”) means the person carrying out the development for which the planning permission has been granted; and

“the 1990 Act” (“*Deddf 1990*”) means the Town and Country Planning Act 1990.

Stopping Up

3. Subject to articles 4, 5 and 6 of this Order the Welsh Ministers authorise the stopping up of the length of highway described in Schedule 1 to this Order and shown by zebra hatching on the deposited plan. The Welsh Ministers are satisfied that the stopping up is necessary to enable development in accordance with planning permission granted under

Prifffordd y Gwneir Gwelliannau Iddi

4. Rhaid gwneud gwelliannau, er boddhad rhesymol y Cyngor, i'r darn o brifffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn, sy'n brifffordd i'w chynnal ar draul y pwrs cyhoeddus at ddibenion Deddf Prifffyrdd 1980(1). Y Cyngor fydd yr awdurdod prifffyrdd sy'n gyfrifol amdani.

Y Darpariaethau sy'n Angenrheidiol neu'n Hwylus cyn Cau Prifffordd

5. Ni chaniateir cau'r darn o brifffordd a ddisgrifir yn Atodlen 1 i'r Gorchymyn hwn—

- hyd nes y bydd y datblygwr wedi darparu, er boddhad rhesymol y Cyngor, blaniau sy'n dangos sut y mae'r darn o brifffordd i'w gau;
- hyd nes y bydd y datblygwr wedi gwella'r darn o brifffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn er boddhad rhesymol y Cyngor;
- hyd nes y bydd y datblygiad a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn wedi ei ddechrau a bod y datblygwr wedi hysbysu'r Cyngor yn ysgrifenedig ei bod yn angenrheidiol cau'r darn o brifffordd er mwyn i'r datblygiad fynd rhagddo; a
- hyd nes y bydd y Cyngor wedi ysgrifennu at y datblygwr i gadarnhau bod paragraffau (a), (b) ac (c) wedi eu bodloni.

Ymgymeryr Statudol a Darparwyr

6. Pan fo gan ymgymeryr statudol gyfarpar o dan y brifffordd, ynddi, arni, drosti, ar ei hyd neu ar ei thraws yn union cyn dyddiad cau'r darn o brifffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn, bydd gan yr ymgymeryr yr un hawliau mewn cysylltiad â'r cyfarpar ag a oedd ganddynt cyn cau'r brifffordd.

Improved Highway

4. There must be improvements made, to the reasonable satisfaction of the Council, to the length of highway described in Schedule 2 to this Order, which is highway maintainable at the public expense for the purposes of the Highways Act 1980(1) and the Council is to be the highway authority responsible for it.

Provisions Necessary or Expedient before Stopping Up

5. The length of highway described in Schedule 1 to this Order must not be stopped up until—

- the developer has provided, to the reasonable satisfaction of the Council, plans showing how the length of highway are to be stopped up;
- the developer has improved the length of highway described in Schedule 2 to this Order to the reasonable satisfaction of the Council;
- the development described in Schedule 3 to this Order has commenced and the developer has informed the Council in writing of the necessity to stop up the length of highway to allow the development to proceed; and
- the Council has confirmed in writing to the developer that paragraphs (a), (b) and (c) are satisfied.

Statutory Undertakers and Providers

6. Where immediately before the length of highway is stopped up, there is under, in, on, over, along or across the highway any apparatus of statutory undertakers or public communications providers then the undertakers or providers continue to have the same rights in respect of the apparatus as they had before the stopping up.

An irregular shaped length of highway directly outside of the property known as Hafod y Bryn, 37 Cae Mair in Beaumaris, Isle of Anglesey, LL58 8YN, and directly opposite the junction of Cae Mair with the public footpath footway of unknown name, with a length of 17.01 metres, a width of 5.78 metres and marked with zebra hatching on the deposited plan.

SCHEDULE 2
Length of highway to be improved

A rectangular shaped length of highway on the highway known as Cae Mair in Beaumaris, Isle of Anglesey, LL58 8YN, located directly opposite of the public footpath footway of unknown name, with a length of 17.01 metres, a width of 1 metre and marked with cross hatching on the deposited plan.

Creation of a new access, together with an extension to the curtilage at Hafod y Bryn, 37 Cae Mair, Beaumaris, Isle of Anglesey, LL58 8YN.
