 - Records of any money, grants, contracts, sponsorship, financial support, or payments received by Welsh Government from Grey2K USA or its representatives.

GREY2K USA Worldwide approached the Deputy First Minister and Cabinet Secretary for Climate Change and Rural Affairs in April 2024 when he was first appointed to the post. The Deputy First Minister declined to meet with the organisation. A copy of the incoming meeting invitation and the decline letter are included below and released under this request.
