## Statutory Register of Historic Parks & Gardens in Wales: Buckland House

Dear Sir/Madam,

I am writing to you since I understand that you own or occupy all, or part, of the historic park and garden at Buckland House.

As you may be aware, the historic significance of Buckland House has been recognised by its inclusion in the non-statutory register of historic parks and gardens in Wales.

### Grade II. Primary reasons for grading:

*The survival of the structure of a grand Edwardian formal garden in a fine position in the Usk valley. The garden and grounds contain some good specimen trees and shrubs and a notable tennis pavilion designed by H. Avray Tipping.*

The Historic Environment (Wales) Act 2016 placed a duty on the Welsh Ministers to compile and maintain a statutory register of historic parks and gardens in Wales. The existing non-statutory register will form the basis of the new statutory one. In preparation for the move to statutory status, the opportunity has been taken to review the extent of all historic parks and gardens currently registered. Before the statutory register is finalised and brought into force during 2019, the Welsh Government's Historic Environment Service (Cadw) will be consulting with owners and occupiers of registered parks and gardens about the proposals resulting from that review.

I therefore enclose a map of Buckland House showing the area proposed for statutory registration.

If you have any comments, please send them to me by 6 November 2019 so that they can be considered before the statutory register is finalised. If you are not the owner or occupier of the entire site, we would be grateful for information about anyone else who has such an interest in the land.

The new register will help to inform decisions about the future of registered sites and does not introduce any additional regulatory controls over and above the current requirement for
