ATISN 26961 – NHS Yearly Tracheostomy Procedures 2025

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 11 May 2026 relating to tracheostomy procedures in 2025.

You requested the following:

- *How many tracheostomies were performed within the Aneurin Bevan University Health Board in 2025?*

Of these procedures:

- *How many patients were successfully decannulated?*
- *How many patients were not successfully decannulated due to compromised airway integrity?*
- *How many unsuccessful cases required transfer to a specialist centre for corrective treatment?*
- *Which specialist centres were chosen for referral for specialist surgery and / or treatment.*
