The Welsh Ministers, as traffic authority(1) for the relevant length of the A40 trunk road, and in exercise of the powers in sections 84(1)(a) and (2), and 124(1)(d) and (3)(b) of, and paragraph 27(1) of Schedule 9 of the Road Traffic Regulation Act 1984(2), make this Order.

The Welsh Ministers have consulted with the Chief Officer of Dyfed-Powys Police and given public notice of their intention to make this Order in accordance with regulations 5(1) and 6(1) of the Secretary of State's Traffic Orders (Procedure) (England and Wales) Regulations 1990(3).

**Title and commencement**

1. The title of this Order is the A40 Trunk Road (Sceddau, Pembrokeshire) (40 mph Speed Limit) Order 202- and it comes into force on \*\*\*\* 202-.

## Restriction

2. No person may drive any motor vehicle(1) at a speed exceeding 40 miles per hour on the length of the A40 trunk road in Scleddau, Pembrokeshire, that extends from a point 369 metres north-west of the centre of its junction with the U3418 road to Fishguard, to a point 275 metres south-east of the centre of the same junction.

## Revocation

3. The A40 Trunk Road (Scleddau, Pembrokeshire) (50 mph Speed Limit) Order 2004(2) is revoked.
