⁵ Firth of Clyde means the area of sea which lies landward of a line drawn from a point on the mainland of Scotland at 55° 17.9' North and 5° 47.8' West (Mull of Kintyre) to a point on the mainland of Scotland at 55° 00.5' North and 5° 09.4' West (Corsewall Point).

⁶ "Scottish inshore waters" means the sea adjacent to the coast of Scotland and to the landward of a limit of 6 nautical miles from the baseline from which the territorial sea is measured, up to the mean high water mark of ordinary spring tides.
