**PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 -

BUILDINGS OF SPECIAL ARCHITECTURAL OR HISTORIC INTEREST
RESURVEYS OF HIRWAUN AND RHIGOS**

As you know the above communities have recently been resurveyed for listable buildings and we propose to issue shortly revised lists for these areas. The lists will be cumulative ones, identifying all buildings in the community which reach the standard for listing as laid down in Annex C Listed Buildings - Principles of Selection in Welsh Office Circular 61/96. Those buildings already listed being shown with the original date of listing against the entry.

I enclose for your attention a copy of the full draft lists. **These should be treated in confidence until the lists have been made statutory and the owners and occupiers of buildings listed for the first time notified.**

We are anxious that the lists should come into effect at the earliest opportunity and would welcome any comments or information you have on both the individual items put forward and the completeness of the selection by **10/07/2002**.

I should also be grateful if you could check the accuracy of the addresses of the buildings proposed for listing, confirm that none have been demolished since this report was prepared nor are currently, or have recently been, the subject of a planning application, identifying in particular any which are the subject of on-going works.
