Following a review of the information previously provided by CIW in response to the December 2024 and March 2026 Freedom of Information requests, and after undertaking further checks of records available to us, we have not identified any additional information held that falls within the scope of the request.

On that basis, we have nothing further to add to the responses already provided (please see copy of responses provided attached). We remain of the view that the previous responses addressed the information held by CIW in connection with its regulatory, monitoring and inspection functions in relation to Tîm Emrallt.

We note that the expanded internal review is considering wider areas such as Integrated Care Fund arrangements, Regional Partnership Board documentation, governance, and accountability records. As previously discussed, these do not appear to fall within records held and searched by CIW and may require consideration by the relevant Welsh Government policy and programme teams.

We would be grateful if CIW could be kept fully sighted on the final Welsh Government response to the FOI please.

Please let me know if there is anything further I can support with.

I hope you're well. An FOI has been received in relation to Tîm Emrallt and we're compiling the information WG holds. The original FOI has been responded to, but a follow-up letter/complaint has been received asking that WG carry out an internal review. As a result of this follow-up letter the scope of the original FOI has been expanded. My colleague redacted s40(2) copied, is leading on this but he's on leave today and tomorrow so I'm just looking into it in his absence. **I want to start by apologising as I have only picked this up myself today. Do you know whether anyone has already been in touch with CIW about this request? If not, I've set out the details below.**

I've come across the attached document in iShare which lists files to be checked for references to Tîm Emrallt. I expect the files are saved in a caveated area in iShare but, having checked the FOI guidance, this doesn't preclude the information from being released under FOI. It just means some information may need to be redacted before being released if it does relate to Tîm Emrallt.

Our request:

- 1) Can you confirm whether you hold any information regarding Tîm Emrallt, which fits within the below scope please.**

2) If you do hold relevant information, can you please provide redacted copies for the purpose of responding to this FOI by 3pm tomorrow/Tuesday?

The original FOI states, " *Please provide the following recorded information:*

Any reports, briefing papers, assessments, reviews, or correspondence referring to Tîm Emrallt, or a Problematic and Harmful Sexual Behaviour (PHSB) service within North Wales.

Any recorded information referring to the governance, accountability, oversight, performance, or effectiveness of Tîm Emrallt.

Any correspondence or reports exchanged between the National Independent Safeguarding Board and the North Wales Safeguarding Board in which Tîm Emrallt, or a Problematic and Harmful Sexual Behaviour (PHSB) service, is discussed.

Any records identifying whether Tîm Emrallt has formed part of any national review, assurance process, thematic review, inspection support, or evaluation undertaken or commissioned by the National Independent Safeguarding Board.

Any recorded information identifying which organisation has responsibility for the governance or accountability of Tîm Emrallt, if such information is held.

For the purposes of this request, "recorded information" includes, but is not limited to:

reports;

meeting papers;

agendas and minutes;

briefing notes;

correspondence;

presentations;

assurance documents;

review documents; and

electronic records.

If no information is held in relation to any part of this request, please confirm that no recorded information is held."

As mentioned above, the scope of the original FOI meant that no relevant information was identified. A follow-up letter says, "*Welsh Government's own published evaluation of the Integrated Care Fund explains that ICF projects were delivered through Regional Partnership Boards and were subject to formal governance, investment planning, monitoring and reporting arrangements.*

In light of this publicly available information, I request that the internal review considers whether searches were undertaken of records that would reasonably be expected to relate to an Integrated Care Fund project, including, where applicable:

Integrated Care Fund investment plans;

Regional Partnership Board submissions and associated records; programme monitoring and evaluation records; governance and accountability documentation relating to funded projects; correspondence relating to the establishment, funding or governance of Tîm Emrallt."

We will be providing the requested relevant documentation alongside a response to this letter, having expanded the scope of the FOI to include the terms mentioned in the follow-up letter. The plan is to clear this with our Deputy Director on Wednesday and with the Chief Social Care Officer for Wales, **redacted s40(2)**, on Thursday this week before it goes to the Minister on Monday.
