Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A465, wedi eu bodloni y dylid gwahardd traffig a/neu gyfyngu arno ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), yn gwneud y Gorchymyn hwn.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A465 (Cylchfan Hardwick, y Fenni, i Ffin Cymru/Lloegr, Sir Fynwy) (Gwaharddiadau a Chyfyngiadau Traffig Dros Dro) 2026 a daw'r Gorchymyn hwn i rym ar 16 Medi 2026.

The Welsh Ministers, as traffic authority for the A465 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A465 Trunk Road (Hardwick Roundabout, Abergavenny, to the Wales/England Border, Monmouthshire) (Temporary Traffic Prohibitions and Restrictions) Order 2026 and it comes into effect on 16 September 2026.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means:

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—

(i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol, neu

(ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw'r cyfnod hwnnw sy'n dechrau am 20:00 o'r gloch ar 16 Medi 2026 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A465 Casnewydd i Amwythig;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys, neu gerbydau sy'n cael eu defnyddio mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

Gwaharddiadau a chyfyngiadau

3. Ni chieff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 50 milltir yr awr ar y darn o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 40 milltir yr awr ar y darn o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

6. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1);

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds, or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director any vehicle being used by the emergency services, or vehicles being used in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A465 Newport to Shrewsbury trunk road;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 20:00 hours on 16 September 2026 and ending when the temporary traffic signs are permanently removed.

Prohibitions and restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road specified in the Schedule to this Order.

4. No person may, during the works period, drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the length of the trunk road specified in the Schedule to this Order.

5. No person may, during the works period, drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 40 miles per hour on the length of the trunk road specified in the Schedule to this Order.

6. No person may, during the works period, drive any motor vehicle other than an exempted vehicle at a speed exceeding 10 miles per hour on the length of the trunk road specified in the Schedule to this Order.

8. Ni chaiff neb, yn ystod cyfnod y gwaith, reidio unrhyw feic pedal ar y darn o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

9. Ni chaiff neb, yn ystod cyfnod y gwaith, gerdded ar y darn o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

Cymhwyso

10.—(1) Ni fydd y gwaharddiadau na'r cyfyngiadau yn erthyglau 3, 4, 5, 6, 7, 8 a 9 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfyn cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

Cyfnod para'r Gorchymyn hwn

11. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

YR ATODLEN

Y darn o gefnffordd yr A465 sy'n ymestyn o'i chyffordd â'r gerbyttfordd gylchredol wrth System Gylchu Hardwick hyd at ffin Cymru/Lloegr, yn Sir Fynwy.

7. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road specified in the Schedule to this Order during such times as the restriction referred to in article 6 is in operation.

8. No person may, during the works period, ride any pedal cycle on the length of the trunk road specified in the Schedule to this Order.

9. No pedestrian may, during the works period, proceed on the length of the trunk road specified in the Schedule to this Order.

Application

10.—(1) The prohibitions and restrictions in articles 3, 4, 5, 6, 7, 8 and 9 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

Duration of this Order

11. The maximum duration of this Order is 18 months.
