Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A483, a thrwy arfer y pwerau a roddir iddynt gan adrannau 82(2) a 83(1) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the relevant length of the A483 trunk road, and in exercise of the powers conferred upon them by sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984(1), make this Order.

Mae Gweinidogion Cymru wedi rhoi hysbysiad cyhoeddus o'u bwriad i wneud y Gorchymyn hwn yn unol ag adran 83(1) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984.

The Welsh Ministers have given public notice of their intention to make this Order in accordance with section 83(1) of the Road Traffic Regulation Act 1984.

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A483 (Y Trallwng, Powys) (Dileu Cyfyngiad) 2026 a daw'r Gorchymyn hwn i rym ar 4 Medi 2026.

1. The title of this Order is the A483 Trunk Road (Welshpool, Powys) (Derestriction) Order 2026 and this Order comes into force on 4 September 2026.

Interpretation

2. Yn y Gorchymyn hwn ystyr "y gefnffordd" ("the trunk road") yw cefnffordd yr A483 Abertawe i Fanceinion.

2. In this Order "the trunk road" ("y gefnffordd") means the A483 Swansea to Manchester trunk road.

Bydd y darn o'r gefnffordd i'r gogledd-ddwyrain o'r Trallwng, o bwynt 185 o fetrau i'r de-orllewin o ganolbwynt ei chyffordd â'r A458 Salop Road hyd at bwynt 183 o fetrau i'r gogledd-ddwyrain o ganolbwynt ei chyffordd â'r A458 Salop Road, yn Sir Powys, yn peidio â bod yn ffordd gyfyngedig at ddibenion adran 81 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984.

Llofnodwyd ar ran y Dirprwy Weinidog dros Drafndiaeth, yn gweithredu o dan awdurdod y Gweinidog Cabinet dros Fenter, Cysylltedd ac Ynni, un o Weinidogion Cymru.

Derestriction

3. The length of the trunk road northeast of Welshpool, from a point 185 metres southwest of the centre-point of its junction with the A458 Salop Road to a point 183 metres northeast of the centre-point of its junction with the A458 Salop Road, in the County of Powys, shall cease to be a restricted road for the purposes of section 81 of the Road Traffic Regulation Act 1984.
