


Regional economic & labour market profile – North Wales, April 2018

The latest headline labour market statistics for North Wales are generally more positive than for Wales.

Compared to Wales; North
Wales has a higher employment
rate and lower unemployment
and economic inactivity rates.
GVA per head and GDHI per
head are both higher in North
Wales, while average earnings
are lower.

About this bulletin

This quarterly statistical bulletin summarises information on the economy and labour market for the North Wales economic region along with comparisons to Wales and the UK.

It is one in a series of four which cover the four economic regions of Wales: North Wales, Mid Wales, South West Wales and South East Wales.

North Wales consists of the following six local authorities: Isle of Anglesey, Gwynedd, Conwy, Denbighshire, Flintshire and Wrexham.

Overall summary

North Wales had total Gross Value Added of £13.6 billion in 2016 which translates as £19,573 per head. This compares to £59.6 billion (£19,140 per head) for Wales. This difference is largely explained by higher economic activity rates but offset somewhat by a higher proportion of elderly residents and net commuting out from the region.

Annual Gross Disposable Household Income per head in North Wales was £17,005 in 2015, lower than the UK average (£19,106) and higher than the Wales average (£16,341). Average full-time weekly earnings in North Wales were £484.10 in 2017, lower than the Wales average (£498.40) and the UK average (£550.40).

Over the latest year, the employment rate increased in North Wales whilst the ILO unemployment rate and the economic inactivity (excluding students) rate both fell. Looking over the longer term, North Wales has seen a bigger improvement in employment and unemployment compared to Wales since 2001, but has not improved by as much in economic inactivity.

North Wales had the highest employment rate, the lowest ILO unemployment rate and second lowest economic inactivity rate, amongst the 4 Welsh Economic Regions. GVA per head was the second highest amongst the 4 regions, GDHI per head was also the second highest and average weekly earnings were the second lowest.

Over the latest year North Wales had the largest increase in the employment rate, the largest decrease in the ILO unemployment rate and the second largest decrease in the inactivity rate. The region had the third largest increase in GVA per head and the largest increase in GDHI per head but the only decrease in average earnings.

Looking over the longer term (change on 1999/2001), North Wales had the largest increase in the employment rate and the second largest decrease in the ILO unemployment rate. It had the third largest decrease in the economic inactivity rate. North Wales had the largest increase in GVA per head and the second largest increase in GDHI per head.


The employment level is the total number of people that are in employment and the employment rate is the percentage of the population that is in employment.

Table 1 shows the latest employment level figures and how these have changed over time. For the year ending December 2017, the number of people in employment in North Wales was 326,100, this is an increase of 8,400 people (2.6 per cent) compared to the same period the year before.

Chart 1 shows the latest employment rates for the economic regions and each authority within North Wales.

Within North Wales, 5 of the 6 authorities had increases in the employment rate over the year. Since 2001, all 6 authorities had increases, with the Isle of Anglesey having the largest (up 9.1 percentage points).


The unemployment level is the total number of people who are unemployed and the unemployment rate is the percentage of the economically active population who are unemployed (using the International Labour Organisation's definition of unemployment).

Table 2 shows the latest unemployment level figures and how these have changed over time. For the year ending December 2017, the number of people who were unemployed in North Wales was 11,200, this is a decrease of 1,900 people (14.6 per cent) compared to the same period the year before.

Chart 2 shows the latest unemployment rates for the economic regions and each authority within North Wales.

Within North Wales, 4 of the 6 authorities had falls in the unemployment rate over the year. Since 2001, 4 of the 6 authorities had falls, with Flintshire having the largest (down 3.0 percentage points).

Economic inactivity – New data (next update June 2018)


The economic inactivity rate is the percentage of the population who are neither in employment or ILO unemployed.

Chart 3 shows the latest economic inactivity rates (excluding students) for the economic regions and each authority within North Wales.

Within North Wales, 5 of the 6 authorities had falls over the year (excluding students). Since 2001, all 6 authorities had falls with Wrexham having the largest (down 9.6 percentage points).

Including students, the economic inactivity rate in North Wales was 22.0 per cent, down 1.8 percentage points over the year. This was lower than the rate for Wales (24.0 per cent) and higher than the rate for the UK (21.8 per cent).

Chart 3: Inactivity rate (excl. students), year to December 2017 (a)





Gross value added (GVA) (next update Dec 2018)

Chart 4: GVA per head, 2016




GVA is the value generated by any unit engaged in the production of goods and services.

Total GVA in North Wales in 2016 was £13.6 billion, up 3.0 per cent over the year and up 80.3 per cent since 1999. This compares to an increase of 4.0 per cent over the year and an increase of 80.9 per cent since 1999 for Wales.

Within North Wales, all 6 authorities had increases in GVA per head over the year, with Wrexham having the largest (up by 4.3 per cent). Since 1999, all 6 authorities had increases, with Flintshire having the largest (up by 74.7 per cent).

Gross disposable household income (GDHI) (next update May 2018)

Chart 5: Annual GDHI per head by NUTS3 level, 2015




GDHI is an estimate of the amount of money that households have available for spending or saving.

Please note, these data are only available at NUTS3 level, therefore data for some economic regions are an approximation. In the chart above, Mid Wales only includes Powys, South West Wales includes Ceredigion and Bridgend and South East Wales excludes Bridgend.

Average weekly earnings in North Wales were down 2.4 per cent over the year compared to an increase of 1.0 per cent for Wales and an increase of 2.2 per cent for the UK.

Within North Wales, only 1 of the 6 authorities had an increase over the year, which was Wrexham with an increase of 1.3 per cent.





In North Wales, there were 2,515 VAT/PAYE registered enterprise births during 2016. This was an increase from 2,365 enterprise births in 2015.

There were 2,250 VAT/PAYE registered enterprise deaths in North Wales in 2016, which was an increase from 2,095 enterprise births in 2015.

The difference in births and deaths may not equal the difference in stock, because businesses may be born and die in the same period and the stock is taken at a single point in time.

Chart 8: VAT/PAYE registered enterprises per 10,000 resident population, 2016 (a)



Business structure (next update Nov 2018)

There were 62,775 enterprises active in North Wales in 2017, of which 94.3 per cent were in the zero or micro size-band (0-9 employees). The percentage in this size-band was similar to that for Wales (94.9 per cent).

Key quality information

Relevance

This bulletin is a compendium publication used to bring together the latest key statistics relating to the economy and labour market for each of the four economic regions in Wales, in the context of the Welsh/UK economy and labour market.

This bulletin, produced by the Welsh Government, provides a summary of the sub-Wales data contained within a range of statistical bulletins and presents those estimates alongside other headline estimates for the economy and labour market for Wales and the UK. These statistics are used by the Welsh Government to monitor the headline statistics for the sub-Wales regions as well as providing comparisons to the UK and Welsh economy The bulletin includes statistics relevant to the Programme for Government and Prosperity for All: economic action plan. This bulletin was produced in response to growing user demand for more local area data which was identified in our user consultation. Our User consultation provides more information on how our outputs are used.

The bulletin is the main vehicle for the publication of results at economic region level for the Welsh labour market from the Annual Population Survey (APS), as produced by the Office for National Statistics (ONS). It also provides Welsh data from Jobcentre plus on the numbers of Jobseeker Allowance claimants and numbers of benefit claimants from the Department of Work and Pensions (DWP).

In addition to these datasets, the bulletin brings together the further datasets, for which the Welsh Government produces separate publications, including average weekly earnings, business demography, workplace employment, business structure and regional accounts data. Further information about these additional datasets can be found in the separate publications themselves.

The <u>Department for Work and Pensions (DWP)</u> are no longer publishing working age benefits claimants by client group. We will no longer publish the Benefits data on StatsWales. We are in the process of identifying a new appropriate source for this data.

Accuracy

Guidance on the use of the bulletins

For further guidance on the use of this bulletin, including quality information and descriptions and comparisons of measures and sources, please refer to the Regional Profile User Guide.

Data Sources and Quality

We have also published a <u>comprehensive data sources guide list</u> which provides a summary of all the main official data sources used by the Economic and Labour Market Statistics branch as well as useful links.

Definitions of regions

The four regions used in this set of bulletins are defined as:

North Wales: Isle of Anglesey, Gwynedd, Conwy, Denbighshire, Flintshire and Wrexham.

Mid Wales: Powys and Ceredigion.

South West Wales: Pembrokeshire, Carmarthenshire, Swansea and Neath Port Talbot.

South East Wales: Bridgend, Rhondda Cynon Taf, Merthyr Tydfil, Caerphilly, Blaenau Gwent,

Torfaen, Vale of Glamorgan, Monmouthshire, Newport and Cardiff.

These definitions are based on the Department for Economy, Skills and Natural Resources economic regions.

Revisions

Where the data is not from the Welsh Government, we follow the revisions policy of the individual Government department. For data from our own outputs, we follow our <u>revisions policy</u>.

Timeliness and punctuality

This is a quarterly bulletin, usually published in January, April, July and October. It is based on the latest version of each of the datasets it includes (see dates given in each of the headings for the next update dates).

Accessibility and clarity

Much of the data in this bulletin can be found on <u>StatsWales</u> which is a free-to-use service that allows visitors to view, manipulate, create and download tables from the most detailed official data on Wales. Links to specific data can be found under the relevant tables, above.

Comparability and coherence

Comparable measures for other UK countries for the data published in this bulletin are published on <u>StatsWales</u> where available. Links to specific data can be found under the relevant tables, above.

National Statistics status

The <u>United Kingdom Statistics Authority</u> has designated these statistics as National Statistics, in accordance with the Statistics and Registration Service Act 2007 and signifying compliance with the <u>Code of Practice for Statistics</u>.

National Statistics status means that official statistics meet the highest standards of trustworthiness, quality and public value.

All official statistics should comply with all aspects of the Code of Practice for Statistics. They are awarded National Statistics status following an assessment by the UK Statistics Authority's regulatory arm. The Authority considers whether the statistics meet the highest standards of Code compliance, including the value they add to public decisions and debate.

It is Welsh Government's responsibility to maintain compliance with the standards expected of National Statistics. If we become concerned about whether these statistics are still meeting the appropriate standards, we will discuss any concerns with the Authority promptly. National Statistics status can be removed at any point when the highest standards are not maintained, and reinstated when standards are restored.

Well-being of Future Generations Act (WFG)

The Well-being of Future Generations Act 2015 is about improving the social, economic, environmental and cultural well-being of Wales. The Act puts in place seven well-being goals for Wales. These are for a more equal, prosperous, resilient, healthier and globally responsible Wales, with cohesive communities and a vibrant culture and thriving Welsh language. Under section (10)(1) of the Act, the Welsh Ministers must (a) publish indicators ("national indicators") that must be applied for the purpose of measuring progress towards the achievement of the Well-being goals, and (b) lay a copy of the national indicators before the National Assembly. The 46 national indicators were laid in March 2016.
